During the nomination and voting process all IASWC members are advised to take note of GBM 2021 recommendations that Key office bearers like Secretary, Joint Secretary should have high credentials records such as (H-index > 10; i10 index at least 10, minimum 10 research paper in his/her credit in high impact factor (NAAS > 8.0) journals related to Soil and Water Conservation.
